Ordered further, That if cloture is invoked, the time until 12:20 p.m. be equally divided between the two Leaders or their designees; and at 12:20 p.m., all post-cloture time be expired, the Senate proceed to vote on confirmation of the nomination; and that if the nomination is confirmed, the motion to reconsider be considered made and laid upon the table, the President be immediately notified of the Senate's action, and the Senate then resume legislative session.
