Ordered, That following Leader remarks on Wednesday, January 10, 2018, the Senate proceed to executive session and resume consideration of the nomination of Thomas Lee Robinson Parker, of Tennessee, to be United States District Judge for the Western District of Tennessee.

Ordered further, That all time during adjournment, recess, morning business, and Leader remarks count post-cloture on the Parker nomination.

Ordered further, That at 2:30 p.m., all post-cloture time on the Parker nomination be considered expired and the Senate vote on confirmation of the nomination with no intervening action or debate.

Ordered further, That if confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.

Ordered further, That with respect to the motions to invoke cloture on the nominations of Michael Lawrence Brown, of Georgia, to be United States District Judge for the Northern District of Georgia and Walter David Counts III, of Texas, to be United States District Judge for the Western District of Texas, the mandatory quorums required under Rule XXII be waived.
