Ordered, That following Leader remarks on Tuesday, May 15, 2018, the Senate proceed to executive session and resume consideration of the nomination of Joel M. Carson III, of New Mexico, to be United States Circuit Judge for the Tenth Circuit.

Ordered further, That at 12 noon on Tuesday, May 15, 2018, notwithstanding the provisions of Rule XXII, the Senate vote on the confirmation of the Carson nomination, that immediately following disposition of the Carson nomination, the Senate vote on confirmation of the nomination of John B. Nalbandian, of Kentucky, to be United States Circuit Judge for the Sixth Circuit, that if either are confirmed, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.

Ordered further, That following disposition of the Nalbandian nomination the Senate recess until 2:15 p.m. (*May 10, 14, 2018.*)

Mitchell Zais (Cal. No. 607)

Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to executive session for the consideration of the nomination of Mitchell Zais, of South Carolina, to be Deputy Secretary of Education.

Ordered further, That there then be 10 hours of debate equally divided in the usual form and that following the use or yielding back of time the Senate vote on the nomination with no intervening action or debate; that if confirmed, the motion to reconsider be considered made and laid upon the table; the President be immediately notified of the Senate's actions, and that no further motions be in order.
