*Ordered*, That following Leader remarks on Tuesday, September 17, 2019, the Senate proceed to executive session and resume consideration of the nomination of John Rakolta, Jr., of Michigan, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the United Arab Emirates.

*Ordered further*, That at 12 noon, notwithstanding the provisions of Rule XXII, the post-cloture time on the Rakolta nomination expire.

*Ordered further*, That following the cloture vote on the nomination of Kenneth A. Howery, of Texas, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Kingdom of Sweden, the Senate recess until 2:15 p.m. to allow for the weekly conference meetings.

*Ordered further*, That if cloture is invoked on the Howery nomination, the post-cloture time expire at 3:30 p.m., and if either of the nominations are confirmed the motions to reconsider be considered made and laid on the table, and the President be immediately notified of the Senate's actions.

*Ordered further*, That following disposition of the Howery nomination, notwithstanding the provisions of Rule XXII, the Senate vote on the cloture motions for the following nominations:

Robert A. Destro, of Virginia, to be Assistant Secretary of State for Democracy, Human Rights, and Labor;

Brent James McIntosh, of Michigan, to be an Under Secretary of the Treasury; and

Brian Callanan, of New Jersey, to be General Counsel for the Department of the Treasury.

*Ordered further*, That with respect to the motions to invoke cloture on the Howery, Destro, McIntosh, and Callanan nominations, the mandatory quorum calls required under Rule XXII be waived. (*Sept. 12, 16, 2019.*)
