UNANIMOUS CONSENT AGREEMENT

Michael Pack (Cal. No. 697)

Ordered, That following Leader remarks on Thursday, June 4, 2020, the Senate proceed to executive session and resume consideration of the nomination of Michael Pack, of Maryland, to be Chief Executive Officer of the Broadcasting Board of Governors for the term of three years.

Ordered further, That at 11:40 a.m., notwithstanding the provisions of Rule XXII, the cloture motion with respect to the Pack nomination ripen, with 20 minutes of debate under the control of the Senator from New Jersey (Mr. Menendez) prior to the vote.

Ordered further, That with respect to the motion to invoke cloture on Pack nomination, the mandatory quorum call required under Rule XXII be waived.

Ordered further, That if cloture is invoked on the Pack nomination, the post-cloture time expire at 1:30 p.m.

Ordered further, That if confirmed, the motion to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (*Jun. 2, 3, 2020.*)
