Ordered, That at 11:30 a.m., March 24, 2022, the Senate vote on confirmation of the nomination of Andrew M. Luger, of Minnesota, to be United States Attorney for the District of Minnesota for the term of four years.

Ordered further, That cloture having been invoked on the nominations of Sarah Elisabeth Geraghty, of Georgia, to be United States District Judge for the Northern District of Georgia and Georgette Castner, of New Jersey, to be United States District Judge for the District of New Jersey, all post-cloture time be considered expired, and the Senate vote on confirmation of the nominations at a time to be determined by the Majority Leader, or his designee, following consultation with the Republican Leader.
