UNANIMOUS CONSENT AGREEMENTS

Protocols to the North Atlantic Treaty of 1949 on the Accession of the Republic of Finland and the Kingdom of Sweden (T. Cal. No. 5) (T. Doc. 117-3)

Ordered, That at 1:30 p.m., on Wednesday, August 3, 2022, the Senate proceed to executive session to consider the Protocols to the North Atlantic Treaty of 1949 on the Accession of the Republic of Finland and the Kingdom of Sweden.

Ordered further, That the treaty be considered as having advanced through the various parliamentary stages up to and including the presentation of the resolution of advice and consent to ratification.

Ordered further, That there be 3 hours for debate, equally divided between the two Leaders, or their designees, on the treaty and resolution of advice and consent to ratification.

Ordered further, That the only amendments in order to the resolution of advice and consent to ratification be Amdt. Nos. 5192 (Mr. Sullivan) and 5191 (Mr. Paul).

Ordered further, That following debate, the Senate vote in relation to the amendments in the order listed.

Ordered further, That upon disposition of the amendments, any committee conditions, declarations, or reservations be agreed to as applicable and the Senate vote on the resolution of advice and consent to ratification, as amended, if amended, with no intervening action or debate.

Ordered further, That if the resolution of advice and consent to ratification is agreed to, the motion to reconsider be considered made and laid upon the table, that the President be immediately notified of the Senate's actions, and the Senate then resume legislative session. (*Aug. 2, 2022.*)

Constance J. Milstein (Cal. No. 922) (PN1466)

Ordered, That at a time to be determined by the Majority Leader in consultation with the Republican Leader the Senate proceed to executive session to consider the nomination of Constance J. Milstein, of New York, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Malta.

Ordered further, That there be 10 minutes of debate equally divided in the usual form.

Ordered further, That upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination.

Ordered further, That if confirmed, the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's actions, and the Senate then resume legislative session. (*Jul. 19, 2022.*)

Cathy Ann Harris (Cal. No. 716) (PN1599)

Ordered, That cloture having been invoked on nomination of Cathy Ann Harris, of Maryland, to be Chairman of the Merit Systems Protection Board, all post-cloture time be considered expired, and the Senate vote on confirmation of the nomination at a time to be determined by the Majority Leader, or his designee, following consultation with the Republican Leader. (*Mar. 30, 2022.*)
