Ordered, That upon the conclusion of morning business on Thursday, September 7, 2023, the Senate proceed to executive session to resume consideration of the nomination of Adriana Debora Kugler, of Maryland, to be a Member of the Board of Governors of the Federal Reserve System for the unexpired term of fourteen years from February 1, 2012, post-cloture.

Ordered further, That at 11:45 a.m., all post-cloture time be considered expired on the Kugler nomination and the Senate vote on confirmation of the nomination.

Ordered further, That with respect to the motion to invoke cloture on the nomination of Anna M. Gomez, of Virginia, to be a Member of the Federal Communications Commission for a term of five years from July 1, 2021, the mandatory quorum call required under Rule XXII be waived.

Ordered further, That if cloture is invoked on the Gomez nomination, all post-cloture time be considered expired at 1:45 p.m.

Ordered further, That if any nominations are confirmed, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Jul. 27 and Sep. 6, 2023.*)
