Ordered further, That with respect to the motions to invoke cloture on the nominations of Julia Kathleen Munley, of Pennsylvania, to be United States District Judge for the Middle District of Pennsylvania and Karla Ann Gilbride, of Maryland, to be General Counsel of the Equal Employment Opportunity Commission for a term of four years, the mandatory quorum calls required under Rule XXII be waived.
