## UNANIMOUS CONSENT AGREEMENTS

*Ordered further,* That if the nomination is confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Mar. 5, 6, 2024.*)
