UNANIMOUS CONSENT AGREEMENTS

John P. Carlin (PN1243)

Ordered further, That the remaining cloture motions filed on Thursday, February 27, 2014 not ripen prior to 2:15 p.m. on Wednesday, March 5, 2014.

Ordered further, That for the purposes of Rule XXII, Friday, February 28, 2014, count as an intervening day.
