Ordered, That following Leader remarks on Thursday, November 9, 2017, the Senate proceed to executive session and resume consideration of the nomination of William L. Wehrum, of Delaware, to be an Assistant Administrator of the Environmental Protection Agency, post-cloture.

Ordered further, That at 11 a.m., there be 30 minutes of post-cloture time remaining on the Wehrum nomination, equally divided between the Leaders or their designees, and that following the use or yielding back of that time, the Senate vote on the confirmation of the Wehrum nomination and that if confirmed, the motion to reconsider be considered made and laid upon the table and the president be immediately notified of the Senate's actions.

Ordered further, That at 1:45 p.m., the Senate vote on the motion to invoke cloture on the nomination of Derek Kan, of California, to be Under Secretary of Transportation for Policy with no intervening action or debate.

Ordered further, That with respect to the motion to invoke cloture on the Kan nomination, the mandatory quorum required under Rule XXII be waived. (*Nov. 2, 8, 2017.*)
