## UNANIMOUS CONSENT AGREEMENTS

*Ordered,* That following Leader remarks on Thursday, May 10, 2018, the Senate proceed to executive session and resume consideration of the nomination of Michael B. Brennan, of Wisconsin, to be United States Circuit Judge for the Seventh Circuit.

*Ordered further,* That at 12 noon, notwithstanding the provisions of Rule XXII, the post-cloture time be considered expired on the Brennan nomination and the Senate vote on confirmation of the nomination with no intervening action or debate.

*Ordered further,* That, if the Brennan nomination is confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.

*Ordered further,* That following disposition of the Brennan nomination, the Senate vote on the motion to invoke cloture on the nomination of Joel M. Carson III, of New Mexico, to be United States Circuit Judge for the Tenth Circuit.

*Ordered further,* That at 1:45 p.m., the vote on the motion to invoke cloture on the nomination of John B. Nalbandian, of Kentucky, to be United States Circuit Judge for the Sixth Circuit occur; and that if cloture is invoked on the Carson and Nalbandian nominations the debate time run concurrently.

*Ordered further,* That with respect to the motions to invoke cloture on the nominations listed below, the mandatory quorums required under Rule XXII be waived:

Joel M. Carson III, of New Mexico, to be United States Circuit Judge for the Tenth Circuit;

John B. Nalbandian, of Kentucky, to be United States Circuit Judge for the Sixth Circuit;

Michael Y. Scudder, of Illinois, to be United States Circuit Judge for the Seventh Circuit; and

Amy J. St. Eve, of Illinois, to be United States Circuit Judge for the Seventh Circuit. (*Apr. 26, May 9, 2018.*)
