UNANIMOUS CONSENT AGREEMENTS

Brian Allen Benczkowski (Cal. No. 639) Paul C. Ney, Jr. (Cal. No. 686)

Ordered, That following Leader remarks on Wednesday, July 11, 2018, the Senate resume consideration of the nomination of Brian Allen Benczkowski, of Virginia, to be an Assistant Attorney General.

Ordered further, That all time during adjournment, Leader remarks, and morning business count post-cloture on the Benczkowski nomination.

Ordered further, That at 2 p.m., notwithstanding the provisions of Rule XXII, all post-cloture time on the Benczkowski nomination be considered expired and the Senate immediately vote on the nomination; that if confirmed, the motion to reconsider be considered made and laid on the table and the President be immediately notified of the Senate's actions and that following disposition of the nomination, the Senate vote on the motion to invoke cloture on the nomination of Paul C. Ney, Jr., of Tennessee, to be General Counsel of the Department of Defense.

Ordered further, That with respect to the motion to invoke cloture on the Ney nomination, the mandatory quorum required under Rule XXII be waived. *(Jun. 28, Jul. 10, 2018.)*

James Blew (Cal. No. 601)

Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to executive session for the consideration of the nomination of James Blew, of California, to be Assistant Secretary for Planning, Evaluation, and Policy Development, Department of Education.

Ordered further, That there be 5 hours of debate, equally divided, and that following the use or yielding back of time the Senate vote on the nomination with no intervening action or debate; that if confirmed, the motion to reconsider be considered made and laid upon the table; the President be immediately notified of the Senate's actions, and that no further motions be in order. *(Jun. 25, 2018.)*
