## UNANIMOUS CONSENT AGREEMENT

*Ordered*, That following Leader remarks on Tuesday, September 24, 2019, the Senate proceed to executive session and resume consideration of the nomination of Joseph Cella, of Michigan, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Fiji, and to serve concurrently and without additional compensation as Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Kiribati, the Republic of Nauru, the Kingdom of Tonga, and Tuvalu

*Ordered further*, That at 11:30 a.m., notwithstanding the provisions of Rule XXII, the cloture motions on the following nominations ripen:

Joseph Cella, of Michigan, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Fiji, and to serve concurrently and without additional compensation as Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Kiribati, the Republic of Nauru, the Kingdom of Tonga, and Tuvalu;

Daniel Habib Jorjani, of Kentucky, to be Solicitor of the Department of the Interior; and

David Fabian Black, of North Dakota, to be Deputy Commissioner of Social Security for a term expiring January 19, 2025.

*Ordered further*, That with respect to the motions to invoke cloture on the Cella, Jorjani, and Black nominations, the mandatory quorum calls required under Rule XXII be waived.

*Ordered further*, That following the cloture vote on the Black nomination the Senate recess until 2:15 p.m. to allow for weekly conference meetings.

*Ordered further*, That following the cloture vote on the Black nomination, notwithstanding the provisions of Rule XXII, the Senate resume consideration of the nomination of Brian McGuire, of New York, to be a Deputy Under Secretary of the Treasury and that at 3:30 p.m. all post-cloture time on the McGuire, Cella, Jorjani, and Black nominations be considered expired.

*Ordered further*, That if any of the nominations are confirmed the motions to reconsider be considered made and laid on the table, and the President be immediately notified of the Senate's actions. (*Sept. 19, 23, 2019.*)
