Wade, of the District of Columbia, to be an Assistant Secretary of Housing and Urban Development, in the order listed.

*Ordered further*, That if cloture is invoked on the nominations, the post-cloture time expire at 2:30 p.m., and the Senate vote on confirmation of the nominations in that order.

*Ordered further*, That if confirmed, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions.

*Ordered further*, That the cloture motions with respect to the nomination of Marvin Kaplan, of Kansas, to be a Member of the National Labor Relations Board for the term of five years expiring August 27, 2025 and the nomination of Lauren McGarity McFerran, of the District of Columbia, to be a Member of the National Labor Relations Board for the term of five years expiring December 16, 2024, ripen following disposition of the Wade nomination.

*Ordered further*, That following the cloture vote on the Wade nomination, the Senate recess until 2:15 p.m. to allow for the weekly conference meetings.
