Ordered further, That following the cloture vote on the Wang nomination, the Senate immediately vote on cloture on the Laroski nomination.

Ordered further, That if cloture is invoked on the Wang nomination, all time be considered expired at 1:45 p.m.

Ordered further, That if cloture is invoked on the Laroski nomination, all time be considered expired and the confirmation vote be at a time to be determined by the Majority Leader in consultation with the Republican Leader.

Ordered further, That if any nominations are confirmed during Thursday's session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Jan. 30, 31, 2024.*)
