## UNANIMOUS CONSENT AGREEMENT

*Ordered*, That on Monday, January 29, 2001, at 2:00 p.m., the Senate proceed to executive session to consider the nomination of Gale Ann Norton, of Colorado, to be Secretary of the Interior; that there be three hours equally divided between the Chairman (Mr. Murkowski) and the Ranking Member (Mr. Bingaman); that there be two hours equally divided between the Majority Leader (Mr. Lott) and the Democratic Leader (Mr. Daschle), or their designees, and that following the use or yielding back of time, the nomination be laid aside.

*Ordered further*, That on Tuesday, January 30, 2001, at 10:00 a.m., the Committee on Environment and Public Works be discharged from the nomination of Christine Todd Whitman, of New Jersey, to be Administrator of the Environmental Protection Agency and the Senate proceed to its immediate consideration; that there be ten minutes under the control of Mr. Corzine, ten minutes under the control of Mr. Torricelli, and that there be ten minutes to be equally divided between the Chairman (Mr. Smith of New Hampshire) and the Ranking Member (Mr. Reid) of the Committee on Environment and Public Works.

*Ordered further*, That at 10:30 a.m., the nomination of Christine Todd Whitman be temporarily laid aside and that the Senate resume consideration of the nomination of Gale Ann Norton; that the debate time be divided as follows:

- Mr. Feingold - 10 minutes
- Ms. Stabenow - 10 minutes
- Mr. Durbin - 15 minutes
- Mr. Wellstone - 15 minutes
- Mrs. Boxer - 30 minutes
- Mr. Murkowski - 30 minutes.

*Ordered further*, That at 2:15 p.m., the Senate proceed to the nomination of Elaine Chao to be the Secretary of Labor and there be fifteen minutes equally divided between the Chairman (Mr. Jeffords) and the Ranking Member (Mr. Kennedy) of the Committee on Health, Education, Labor, and Pensions, and fifteen minutes under the control of Mr. Wellstone; that following the use or yielding back of time, the Senate proceed to vote on the nomination of Elaine Chao, to be followed by a vote on the nomination of Gale Ann Norton, to be followed by a vote on the nomination of Christine Todd Whitman.

*Ordered further*, That following the votes the President be notified of the Senates action and the Senate return to legislative session.

*Ordered further*, That either the Majority Leader (Mr. Lott) or the Democratic Leader (Mr. Daschle) may vitiate the agreement relative to the nomination of Elaine Chao prior to the vote and that the Senate will not proceed if the nomination of Elaine Chao and accompanying papers have not been received.
