UNANIMOUS CONSENT AGREEMENT

Ordered, That on Friday, July 20, 2001, at 9:15 a.m., the Senate proceed to executive session to consider en bloc the nominations of Roger L. Gregory, of Virginia, to be United States Circuit Judge for the Fourth Circuit (Cal. No. 250), Sam E. Haddon, of Montana, to be United States District Judge for the District of Montana (Cal. No. 245), and Richard F. Cebull, of Montana, to be United States District Judge for the District of Montana (Cal. No. 246) and that there be 30 minutes divided equally between Mr. Leahy and Mr. Hatch, or their designees.

Ordered further, That at 9:45 a.m. the Senate vote on the confirmations of the nominations; that upon the disposition of the nominations the Senate consider and confirm the nominations of Ralph F. Boyd, Jr., of Massachusetts, to be an Assistant Attorney General (Cal. No. 247) and Robert D. McCallum, Jr., of Georgia, to be an Assistant Attorney General (Cal. No. 248) and that following the confirmations, the President be immediately notified of the Senates action, the motions to reconsider be laid upon the table en bloc, and the Senate immediately return to legislative session.
