UNANIMOUS CONSENT AGREEMENT

Ordered, That on Thursday, January 20, 2003, at a time determined by the Majority Leader, with the concurrence of the Democratic Leader, the Senate proceed to executive session and that the nomination of Gordon England, of Texas, to be Deputy Secretary of Homeland Security be discharged from the Committee on Governmental Affairs;

Ordered further, That the Senate then proceed to its consideration; there be 20 minutes of debate equally divided between the Chairman (Ms. Collins) and the Ranking member (Mr. Lieberman);

Ordered further, That following the use or yielding back of time the Senate proceed to a vote on the confirmation, with no intervening action or debate; further, that following the vote the President be immediately notified of the Senate's action, and the Senate then resume legislative session.
