Ordered further, That following debate on April 11, 2003, the nomination be set aside and the Senate resume consideration on Monday, April 28, 2003, for debate only; that following debate on Monday, the nomination be set aside and on Tuesday, April 29, 2003, at a time to be determined by the Majority Leader, after consultation with the Democratic Leader, the Senate proceed to a vote on the confirmation of the nomination, with no intervening action or debate.
