## **UNANIMOUS CONSENT AGREEMENTS**

### **(Thomas C. Dorr [Cal. No. 101])**

*Ordered*, That relative to the motion to invoke cloture on the nomination of Thomas C. Dorr, of Iowa, to be Under Secretary of Agriculture for Rural Development, the mandatory quorum under Rule XXII be waived.
