**UNANAMOUS CONSENT AGREEMENT  
DEBRA ANN LIVINGSTON (CAL. NO. 104)**

*Ordered,* That notwithstanding the provisions of rule XXII, when the Senate completes its action on S. 1082, it proceed to executive session to consider the nomination of Debra Ann Livingston, of New York, to be United States Circuit Judge for the Second Circuit; that there be 3 hours for debate equally divided between the Chairman and Ranking Member of the Committee on the Judiciary or their designees; provided further, that upon the use, or yielding back, of time the Senate, without any intervening action, vote on the nomination; provided further, that the motion to reconsider be laid on the table; the President be immediately notified of the Senate's action and the Senate then return to legislative session.
