Ordered, That on Tuesday, June 10, 2008, after the cloture vote(s) with respect S. 3044 and H.R. 6049, regardless of the outcome and notwithstanding Rule 22, that the Senate then proceed to executive session, to consider concurrently the nominations of Mark S. Davis, of Virginia, to be United States District Judge for the Eastern District of Virginia, David Gregory Kays, of Missouri, to be United States District Judge for the Western District of Missouri and Stephen N. Limbaugh, Jr., of Missouri, to be United States District Judge for the Eastern District of Missouri, that there be a total of 10 minutes equally divided and controlled between the Chairman and Ranking Member of the Committee on the Judiciary; that upon the use or yielding back of time, the Senate proceed to vote on confirmation of each nomination in the order listed above; that there be 2 minutes between each vote, and after the first vote, the vote time be limited to 10 minutes each; that upon confirmation, the motions to reconsider be laid upon the table, en bloc; no further motions be in order; the President be immediately notified of the Senate's action and the Senate resume legislative session, without further intervening action or debate, and the Senate then stand in recess until 2:15 p.m.
