## UNANIMOUS CONSENT AGREEMENT

### **Ben S. Bernanke (Cal. No. 641)**

*Ordered*, That on Thursday, January 28, 2010, upon disposition of H.J. Res. 45 the Senate proceed to executive session; that there be 60 minutes of debate prior to the cloture vote on the nomination of Ben S. Bernanke, of New Jersey, to be Chairman of the Board of Governors of the Federal Reserve System, with the time equally divided and controlled between the Leaders or their designees.

*Ordered further*, That relative to the cloture motion filed on the nomination of Ben S. Bernanke, the mandatory quorum required under Rule XXII be waived.
