UNANIMOUS CONSENT AGREEMENT
Roy Bale Dalton, Jr. (Cal. No. 74)
Kevin Hunter Sharp (Cal. No. 76)

Ordered, That at 4:30 p.m. on Monday, May 2, 2011, the Senate proceed to executive session to consider the following nominations: Roy Bale Dalton, Jr., of Florida, to be United States District Judge for the Middle District of Florida, and Kevin Hunter Sharp, of Tennessee, to be United States District Judge for the Middle District of Tennessee; provided further, that there be one hour for debate equally divided in the usual form; that upon the use or yielding back of time, the nomination of Roy Bale Dalton, Jr. be confirmed and the Senate proceed to vote without any intervening action or debate on the nomination of Kevin Hunter Sharp; that the motions to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order to any of the nominations; that the President be immediately notified of the Senate's actions and the Senate resume legislative session.
