## UNANIMOUS CONSENT AGREEMENT

### David Medine (Cal. No. 42)

*Ordered*, That at a time to be determined by the Majority Leader, in consultation with the Republican Leader, the Senate proceed to executive session to consider the nomination of David Medine, of Maryland, to be Chairman and Member of the Privacy and Civil Liberties Oversight Board.

*Ordered further*, That there be 1 hour for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination; the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order to the nomination; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
