Ordered, That upon the conclusion of morning business on Wednesday, June 18, 2025, the Senate proceed to executive session and resume consideration of the nomination of Rodney Scott, of Oklahoma, to be Commissioner of U.S. Customs and Border Protection, Department of Homeland Security.

Ordered further, That at 12 noon, notwithstanding Rule XXII, the Senate vote on the motion to invoke cloture on the Scott nomination.

Ordered further, That following the cloture vote on the Scott nomination, the Senate vote on confirmation of the nomination of Olivia Trusty, of Maryland, to be a Member of the Federal Communications Commission for a term of five years from July 1, 2025.

Ordered further, That if cloture is invoked on the Scott nomination, all post-cloture time be expired and the Senate vote on confirmation of the nomination at 1:45 p.m.

Ordered further, That if any nominations are confirmed during Wednesday's sessions of the Senate, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (*June 17, 2025.*)
