
JIMMY CARTER

President Carter vetoed thirty-one bills, of which thirteen were regular vetoes and 18 were pocket vetoes. Two were overridden (Item Nos. 2385 and 2386).

Ninety-fifth Congress, First Session

Regular Vetoes

2362 S. 1811.

To authorize appropriations for the Energy Research and Development Administration.

Vetoed on November 5, 1977. The veto message was laid before the Senate and printed as S. Doc. 95-73. (123 Cong. Rec. 37455).

Veto unchallenged.

2363 H.R. 2521.

To provide for the mandatory inspection of domesticated rabbits slaughtered for human food.

Vetod on November 9, 1977. The veto message was laid before the House, referred to the Committee on Agriculture, and printed as H. Doc. 95-261. (123 Cong. Rec. 37513; 38003).

Veto unchallenged.

Ninety-fifth Congress, Second Session

Regular Vetoes

2364 H.R. 3161.

To improve the basic work of firefighting personnel of executive agencies.

Vetoed on June 19, 1978. The veto message was laid before the House, referred to the Committee on Post Office and Civil Service, and printed as H. Doc. 95-358. (124 Cong. Rec. 18311; 19332-19334).

Veto unchallenged.

2365 H.R. 10882.

To authorize appropriations to carry out conservation programs on military and public lands.

Vetoed on July 10, 1978. The veto message was laid before the House, referred to the Committee on Merchant Marine and Fisheries, and printed as H. Doc. 95-368. (124 Cong. Rec. 20059).

Veto unchallenged.

2366 H.R. 10929.

Department of Defense Appropriation Authorization Act for the fiscal year 1979.

Vetoed on August 17, 1978. The veto message was laid before the House and printed as H. Doc. 95-377. (124 Cong. Rec. 28082).

The House sustained the veto on September 7, 1978, by a vote of 191 yeas to 206 nays. (124 Cong. Rec. 28361).

Veto sustained.

2367 H.R. 12928.

Energy and Water Development Appropriation Act, for the fiscal year ending September 30, 1979.

Vetoed on October 5, 1978. The veto message was laid before the House, referred to the Committee on Appropriations, and printed as H. Doc. 95-393. (124 Cong. Rec. 33704).

The House sustained the veto on October 5, 1978, by a vote of 223 yeas to 190 nays. (124 Cong. Rec. 33727).

Veto sustained.

Pocket Vetoes

2368 S. 1104.

To establish the Legionville National Historic Site in Pennsylvania.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 23, 1978. (124 Cong. Rec. 38084). A Presidential message was received by Congress on November 2, 1978. (124 Cong. Rec. 38087).

2369 S. 1503.

To provide for the payment of losses incurred as a result of the ban on Tris.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 27, 1978. (124 Cong. Rec. 38085). A Presidential message was received by Congress on November 15, 1978. (124 Cong. Rec. 38087).

2370 S. 2416.

To extend for two years the assistance program for nurse training.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 30, 1978. (124 Cong. Rec. 38085). A Presidential message was received by Congress on November 10, 1978. (124 Cong. Rec. 38088).

2371 H.R. 6536.

To establish a sound basis for financing retirement benefits for personnel of the District of Columbia.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 24, 1978. (124 Cong. Rec. 38779). A Presidential message was received by Congress on November 4, 1978. (124 Cong. Rec. 38784).

2372 H.R. 9370.

To provide for the development of aquaculture in the United States.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 6, 1978. (124 Cong. Rec. 35831). A Presidential message was received by Congress on October 18, 1978. (124 Cong. Rec. 38786).

2373 H.R. 9518.

Shipping Act Amendments.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 24, 1978. (124 Cong. Rec. 38779). A Presidential message was received by Congress on November 4, 1978. (124 Cong. Rec. 38785).

2374 H.R. 9937.

To amend the One Bank Holding Company Act of 1970.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 31, 1978. (124 Cong. Rec. 38781). A Presidential message was received by Congress on November 11, 1978. (124 Cong. Rec. 38786).

2375 H.R. 11092.

The Navajo and Hopi Indian Relocation Commission Amendments.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 24, 1978. (124 Cong. Rec. 38780). A Presidential message was received by Congress on November 4, 1978. (124 Cong. Rec. 38784).

2376 H.R. 11445.

To amend the Small Business Act and the Small Business Investment Act.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 24, 1978. (124 Cong. Rec. 38771). A Presidential message was received by Congress on October 25, 1978. (124 Cong. Rec. 38783).

2377 H.R. 11545.

Meat and Livestock Import Amendments.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 31, 1978. (124 Cong. Rec. 38781). A Presidential message was received by Congress on November 11, 1978. (124 Cong. Rec. 38785).

2378 H.R. 11580.

To make lawful certain activities concerning certain foreign and domestic legal lotteries.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 24, 1978. (124 Cong. Rec. 38780). A Presidential message was received by Congress on November 4, 1978. (188 S. Jour., 852).

2379 H.R. 11861.

To establish a Navy-Maritime Advisory Board.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 24, 1978. (124 Cong. Rec. 38780). A Presidential message was received by Congress on November 4, 1978. (124 Cong. Rec. 38784).

2380 H.R. 13719.

To offset the loss in tax revenues incurred by Guam and the Virgin Islands.

Pocket veto occurred after the 2d session of the 95th Congress adjourned sine die on October 15, 1978. The bill was presented to the President on October 24, 1978. (124 Cong. Rec. 38780). A Presidential message was received by Congress on November 4, 1978. (124 Cong. Rec. 38785).

2381 S. 2096.

To provide for a study of the long-term health effects in humans of exposure to dioxins.

Vetoed on January 2, 1980. The veto message was laid before the Senate and printed as S. Doc. 96-39. (126 Cong. Rec. 6).

Veto unchallenged.

Ninety-sixth Congress, Second Session

Regular Vetoes

2382 S. 1464.

To acquire land for the benefit of the Mille Lacs Band of Minnesota Chippewa Indians.

Vetoed on October 11, 1980. The veto message was laid before the Senate and printed as Presidential Message 251. (126 Cong. Rec. 29370).

Veto unchallenged.

2383 H.R. 5036.

To convey land in Colorado to the Ute Mountain Ute Tribe.

Vetoed on June 6, 1980. The veto message was laid before the House, referred to the Committee on Interior and Insular Affairs, and printed as H. Doc. 96-324. (126 Cong. Rec. 13655).

Veto unchallenged.

2384 H.R. 5235.

To revise the special pay provisions for certain uniformed services health professionals.

Vetoed on March 11, 1980. The veto message was laid before the House, referred to the Committee on Armed Services, and printed as H. Doc. 96-280. (126 Cong. Rec. 5250, 5372).

Veto unchallenged.

2385 H.R. 7102.

To promote the recruitment and retention of health care personnel in the Department of Medicine and Surgery in the Veterans Administration.

Vetoed on August 22, 1980. The veto message was laid before the House and printed as H. Doc. 96-362. (126 Cong. Rec. 23050).

The House overrode the veto on August 26, 1980 by a vote of 401 yeas to 5 nays. (126 Cong. Rec. 23107).

The Senate overrode the veto on August 26, 1980 by a vote of 85 yeas to 0 nays. (126 Cong. Rec. 23237).

Veto overridden. (94 Stat. 1030; Public Law 96-330).

2386 H.R. 7428.

To extend the present public debt limit through June 30, 1980.

Vetoed on June 5, 1980. The veto message was laid before the House and printed as H. Doc. 96-323. (126 Cong. Rec. 13523).

The House overrode the veto on June 5, 1980 by a vote of 335 yeas to 34 nays. (126 Cong. Rec. 13524).

The Senate overrode the veto on June 6, 1980 by a vote of 68 yeas to 10 nays. (126 Cong. Rec. 13593).

Veto overridden. (94 Stat. 439; Public Law 96-264).

2387 H.R. 7584.

Departments of State, Justice, and Commerce Appropriations, for the fiscal year ending September 30, 1979.

Vetoed on December 13, 1980. The veto message was laid before the House, referred to the Committee on Appropriations, and printed as H. Doc. 96-397. (126 Cong. Rec. 34098).

Veto unchallenged.

Pocket Vetoes

2388 S. 442

For the relief of Isaac Hulner of Kansas City, Missouri.

Pocket veto occurred after the 2d session of the 96th Congress adjourned sine die on December 16, 1980. The bill was presented to the President on December 16, 1980. (126 Cong. Rec. 34375). A Presidential message was received by Congress on December 30, 1980. (190 S. Jour. 820; see also 17 Weekly Comp. of Pres. Doc. 2846, January 5, 1981).

2389 S. 1097.

To establish a national tourism policy.

Pocket veto occurred after the 2d session of the 96th Congress adjourned sine die on December 16, 1980. The bill was presented to the President on December 13, 1980. (126 Cong. Rec. 34020). A Presidential message was received by Congress on December 30, 1980. (190 S. Jour. 819; see also 16 Weekly Comp. of Pres. Doc. 2838, December 19, 1980).

2390 H.R. 4386.

For the relief of Mr. and Mrs. Clarence Oveson.

Pocket veto occurred after the 2d session of the 96th Congress adjourned sine die on December 16, 1980. The bill was presented to the President on December 15, 1980. (126 Cong. Rec. 34196). A Presidential message was received by Congress on December 30, 1980. (126 Cong. Rec. 34415).

2391 H.R. 5888.

To provide death benefits to survivors of Federal law enforcement officers and firefighters.

Pocket veto occurred after the 2d session of the 96th Congress adjourned sine die on December 16, 1980. The bill was presented to the President on December 12, 1980. (126 Cong. Rec. 34196). A Presidential message was received by Congress on December 30, 1980. (126 Cong. Rec. 34414).

2392 H.R. 6257.

To convey certain National Forest System lands.

Pocket veto occurred after the 2d session of the 96th Congress adjourned sine die on December 16, 1980. The bill was presented to the President on December 18, 1980. (126 Cong. Rec. 34412). A Presidential message was received by Congress on December 30, 1980. (126 Cong. Rec. 34415).
