

President Ford vetoed sixty-six bills, of which forty-eight were regular vetoes and eighteen were pocket vetoes. Twelve were overridden (Item Nos. 2304, 2305, 2307, 2308, 2323, 2329, 2335, 2336, 2338, 2342, 2348, and 2354).

Ninety-third Congress, Second Session¹

Regular Vetoes

2296 S. 3537.

To modify section 204 of the Flood Control Act of 1965.

Vetoed December 17, 1974. The veto message was laid before the Senate. (120 Cong. Rec. 40607).

Veto unchallenged.

2297 H.R. 5094.

To amend Title 5, United States Code, to provide for the reclassification of positions of deputy U.S. marshal.

Vetoed August 12, 1974. The veto message was laid before the House, referred to the Post Office and Civil Service Committee, and printed as H. Doc. 93-336. (120 Cong. Rec. 28162).

Veto unchallenged.

2298 H.R. 6191.

To amend the Tariff Schedules of the United States to provide that certain forms of zinc be admitted free of duty.

Vetoed November 26, 1974. The veto message was laid before the House and printed as H. Doc. 93-397. (120 Cong. Rec. 37426).

The House sustained the veto on December 3, 1974 by a vote of 249 yeas to 150 nays. (120 Cong. Rec. 37889).

Veto sustained.

2299 H.R. 6624.

For the relief of Alvin W. Burt, Jr., Eileen Wallace Kennedy Pope, and David Douglas Kennedy, a minor.

Vetoed October 29, 1974. The veto message was laid before the House and printed as H. Doc. 93-378. (120 Cong. Rec. 36247).

The House sustained the veto on November 20, 1974 by a vote of 236 yeas to 163 nays. (120 Cong. Rec. 36634).

Veto sustained.

Note—President Ford vetoed five bills during the October 17 to November 18, 1974 adjournment period. These bills were H.R. 6624 (Item No. 2299), H.R. 7768 (Item No. 2300), H.R. 11541 (Item No. 2302), H.R. 13342 (Item No. 2306), and H.R. 14225 (Item No. 2307). The bills were returned to the Clerk of the House with a message claiming that they had been pocket vetoed. Despite the pocket veto claim, Congress considered them to be regular vetoes and they are listed here and in accompanying tables as such. The veto of H.R. 14225 (Item No. 2307) was overridden by both chambers, but the Administration failed to promulgate it as law. Senator Edward Kennedy amended a pending pocket veto claim (Item No. 2293) to include H.R. 14225. The court held in *Kennedy v. Jones* (412 F.Supp. 353 (D.D.C. 1976)) that pocket vetoes could not be used except after adjournment sine die unless Congress failed to appoint individuals to receive messages. This decision reaffirmed *Kennedy v. Sampson* (Item No. 2262). The provisions of H.R. 14225 were identical to H.R. 17503 which became Public Law 93-516 (88 Stat. 1617). Therefore, H.R. 14225 was not assigned a public law number.

2300 H.R. 7768.

For relief of Nolan Sharp.

Vetoed October 29, 1974. The veto message was laid before the House and printed as H. Doc. 93-379. (120 Cong. Rec. 36248).

Veto unchallenged.

Note—This veto was the subject of a pocket veto claim. *See* the note for H.R. 6624 (Item No. 2299).

2301 H.R. 10626.

To authorize the Secretary of the Interior to sell reserved phosphate interests of the United States in certain lands in Florida to John Carter and Martha B. Carter.

Vetoed September 30, 1974. The veto message was laid before the House, referred to the Committee on Interior and Insular Affairs, and printed as H. Doc. 93-363. (120 Cong. Rec. 33023).

Veto unchallenged.

2302 H.R. 11541.

To amend the National Wildlife Refuge System Administration Act of 1966 in order to strengthen the standards under which the Secretary of the Interior may permit certain uses to be made of areas within the system and to require payment of the fair market value of rights-of-way or other interests granted in such areas in connection with such uses.

Vetoed October 22, 1974. The veto message was laid before the House, referred to the Committee on Merchant Marine and Fisheries, and printed as H. Doc. 93-382. (120 Cong. Rec. 36245).

Veto unchallenged.

Note—This veto was the subject of a pocket veto claim. *See* the note for H.R. 6624 (Item No. 2299).

2303 H.R. 11873.

To authorize the Secretary of Agriculture to encourage and assist the several States in carrying out a program of animal health research.

Vetoed August 14, 1974. The veto message was laid before the House, referred to the Committee on Agriculture, and printed as H. Doc. 93-337. (120 Cong. Rec. 28367).

Veto unchallenged.

2304 H.R. 12471.

To amend section 552 of Title 5, United States Code, known as the Freedom of Information Act.

Vetoed October 17, 1974. The veto message was laid before the House and printed as H. Doc. 93-383. (120 Cong. Rec. 36243).

The House overrode the veto on November 21, 1974 by a vote of 371 yeas to 31 nays. (120 Cong. Rec. 36622).

The Senate overrode the veto on November 21, 1974 by a vote of 65 yeas to 27 nays. (120 Cong. Rec. 36865).

Veto overridden. (88 Stat. 1561; Public Law 93-502).

2305 H.R. 12628.

To amend Title 38, United States Code, to increase the rates of vocational rehabilitation, educational assistance, and special training allowance paid to eligible veterans and other persons.

Vetoed November 26, 1974. The veto message was laid before the House and printed as H. Doc. 93-396. (120 Cong. Rec. 37426).

The House overrode the veto on December 3, 1974 by a vote of 394 yeas to 10 nays. (120 Cong. Rec. 37874).

The Senate overrode the veto on December 3, 1974 by a vote of 90 yeas to 1 nay. (120 Cong. Rec. 37836).

Veto overridden. (88 Stat. 1578; Public Law 93-508).

2306 H.R. 13342.

To amend the Farm Labor Contract Registration Act of 1963 by extending its coverage and effectuating its enforcement.

Vetoed October 29, 1974. The veto message was laid before the House, referred to the Committee on Education and Labor, and printed as H. Doc. 93-380. (120 Cong. Rec. 36246).

Veto unchallenged.

Note—This veto was the subject of a pocket veto claim. *See* the note for H.R. 6624 (Item No. 2299).

2307 H.R. 14225.

To amend and extend the Rehabilitation Act of 1973 for one additional year.

Vetoed October 29, 1974. The veto message was laid before the House and printed as H. Doc. 93-381. (120 Cong. Rec. 36246).

The House overrode the veto on November 20, 1974 by a vote of 398 yeas to 7 nays. (120 Cong. Rec. 36614).

The Senate overrode the veto on November 21, 1974 by a vote of 90 yeas to 1 nay. (120 Cong. Rec. 36842, 36849, 36882).

Veto overridden.

Note—A Public Law number was not assigned to this bill due to the signing into law of an identical bill, H.R. 17503, which became Public Law 93-516; 88 Stat. 1617. *See* the note for H.R. 6624 (Item No. 2299).

2308 H.R. 15301.

To amend the Railroad Retirement Act of 1937 to revise the retirement system for employees of employers covered thereunder.

Vetoed October 12, 1974. The veto message was laid before the House and printed as H. Doc. 93-371. (120 Cong. Rec. 35609).

The House overrode the veto on October 15, 1974 by a vote of 360 yeas to 12 nays. (120 Cong. Rec. 35616).

The Senate overrode the veto on October 16, 1974 by a vote of 72 yeas to 1 nay. (120 Cong. Rec. 35893).

Veto overridden. (88 Stat. 1305; Public Law 93-445).

2309 H.R. 15323.

To amend the Atomic Energy Act of 1954, as amended, to revise the method of proving for public remuneration in the event of a nuclear incident.

Vetoed October 12, 1974. The veto message was laid before the House and printed as H. Doc. 93-370. (120 Cong. Rec. 35617).

Veto unchallenged.

2310 H.J. Res 1131.

Making further appropriations for the fiscal year 1975.

Vetoed October 14, 1974. The veto message was laid before the House and printed as H. Doc. 93-369. (120 Cong. Rec. 35606).

The House sustained the veto on October 15, 1974 by a vote of 223 yeas to 135 nays. (120 Cong. Rec. 35608).

Veto sustained.

2311 H.J. Res. 1163.

Making further appropriations for the fiscal year 1975.

Vetoed October 17, 1974. The veto message was laid before the House and printed as H. Doc. 93-374. (120 Cong. Rec. 36018).

The House sustained the veto on October 17, 1974 by a vote of 161 yeas to 83 nays. (120 Cong. Rec. 36018).

Veto sustained.

Pocket Vetoes

2312 S. 425.

To provide for the cooperation between the Secretary of the Interior and the States with respect to the regulation of surface mining operations, and the acquisition and reclamation of abandoned mines.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 18, 1974. (120 Cong. Rec. 40734). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41996).

2313 S. 3341.

To revise certain provisions of Title 5, United States Code, relating to per diem and mileage and expenses of employees and other individuals traveling on official business.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 19, 1974. (120 Cong. Rec. 41132). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41998).

2314 S. 3943.

To extend the time for using funds appropriated to carry out the Rural Environmental Assistance Program (REAP) and the Rural Environmental Conservation Program (RECP) for the fiscal years ending June 30, 1973, and June 30, 1974.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 24, 1974. (120 Cong. Rec. 41770). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41998).

2315 S. 4206.

To provide price support for milk at not less than 90 percent of the parity price therefor.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 24, 1974. (120 Cong. Rec. 41770). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41997).

2316 H.R. 2933.

To improve the quality of unshelled filberts and shelled filberts for marketing in the United States.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 22, 1974. (120 Cong. Rec. 41993). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41997).

2317 H.R. 8193.

To require that a percentage of oil imports be carried on U.S. flag vessels.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 18, 1974. (120 Cong. Rec. 40963). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41996).

2318 H.R. 11897.

To name the United States Courthouse and Federal Office Building at 110 Michigan Street, N.W., Grand Rapids, Michigan, the "Gerald R. Ford Federal Office Building."

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 23, 1974. (120 Cong. Rec. 41994). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41998).

2319 H.R. 11929.

To amend section 15d of the Tennessee Valley Authority Act of 1933 to provide that expenditure for pollution control facilities will be credited against required power investment return payments and repayments.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 12, 1974. (120 Cong. Rec. 39383). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41996).

2320 H.R. 13296.

To authorize appropriations for the fiscal year 1975 for certain maritime programs of the Department of Commerce.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 23, 1974. (120 Cong. Rec. 41994). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41998).

2321 H.R. 14214.

To amend the Public Health Service Act and related laws, to revise and extend programs of health revenue sharing and health services.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20, 1974. The bill was presented to the President on December 12, 1974. (120 Cong. Rec. 39383). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41996).

2322 H.R. 17085.

To amend Title VIII of the Public Health Service Act to revise and extend the programs of assistance under that title for nurse training.

Pocket veto occurred after the 2d session of the 93d Congress had adjourned sine die on December 20,

1974. The bill was presented to the President on December 24, 1974. (120 Cong. Rec. 41994). A Presidential message was received by the 1st session of the 94th Congress on January 10, 1975. (120 Cong. Rec. 41997).

To amend Title III of the Public Health Service Act to revise and extend the programs of assistance under that title for nurse training and to revise and extend programs of health revenue sharing and health services.

Vetoed July 26, 1975. The veto message was laid before the Senate, and printed as S. Doc. 94-92. (121 Cong. Rec. 25147).

The Senate overrode the veto on July 26, 1975 by a vote of 67 yeas to 15 nays. (121 Cong. Rec. 25153).

The House overrode the veto on July 29, 1975 by a vote of 384 yeas to 43 nays. (121 Cong. Rec. 25514).

Veto overridden. (89 Stat. 304; Public Law 94-63).

2324 S. 1849.

To extend the Emergency Petroleum Allocation Act.

Vetoed September 9, 1975. The veto message was laid before the Senate and printed as S. Doc. 94-102. (121 Cong. Rec. 28199).

The Senate sustained the veto on September 10, 1975 by a vote of 61 yeas to 39 nays. (121 Cong. Rec. 28489).

Veto sustained.

2325 H.R. 12.

To amend Title 3, United States Code, to provide for the protection of foreign diplomatic missions, to increase the size of the Executive Protective Service.

Vetoed December 1, 1975. The veto message was laid before the House, referred to the Committee on Public Works and Transportation, and printed as H. Doc. 94-312. (121 Cong. Rec. 37888).

Veto unchallenged.

2326 H.R. 25.

To provide for the cooperation between the Secretary of the Interior and the States with respect to the regulation of surface coal mining operations, and the acquisition and reclamation of abandoned mines.

Vetoed May 20, 1975. The veto message was laid before the House, referred to the Committee on Inte-

rior and Insular Affairs, and printed as H. Doc. 94-160. (121 Cong. Rec. 15421).

The House sustained the veto on June 10, 1975 by a vote of 278 yeas to 143 nays. (121 Cong. Rec. 17982).
Veto sustained.

2327 H.R. 1767.

To suspend for a 90-day period the authority of the President under section 232 of the Trade Expansion Act of 1962 or any other provision of law to increase tariffs, or to take any other import adjustment action, with respect to petroleum or products derived therefrom; to negate any such action which may be taken by the President after January 15, 1975 and before the beginning of such 90-day period.

Vetoed March 4, 1975. The veto message was laid before the House, referred to the Committee on Ways and Means, and printed as H. Doc. 94-70. (121 Cong. Rec. 5220).

Veto unchallenged.

2328 H.R. 4035.

To provide for more effective congressional review of administrative actions which exempt petroleum products from the Emergency Petroleum Allocation Act of 1973, or which result in a major increase in the price of domestic crude oil; and to provide for an interim extension of certain expiring energy authorities.

Vetoed July 21, 1975. The veto message was laid before the House, referred to the Committee on Interstate and Foreign Commerce, and printed as H. Doc. 94-218. (121 Cong. Rec. 23959).

Veto unchallenged.

2329 H.R. 4222.

To amend the National School Lunch and Child Nutrition Acts.

Vetoed October 3, 1975. The veto message was laid before the House and printed as H. Doc. 94-273. (121 Cong. Rec. 31587).

The House overrode the veto on October 7, 1975 by a vote of 397 yeas to 18 nays. (121 Cong. Rec. 32054).

The Senate overrode the veto on October 7, 1975 by a vote of 79 yeas to 13 nays. (121 Cong. Rec. 32021).

Veto overridden. (89 Stat. 511; Public Law 94-105).

2330 H.R. 4296.

To adjust target prices, loan and purchase levels on the 1975 crops of upland cotton, corn, wheat and soybeans, to provide price support for milk at 85 per cent of parity with quarterly adjustments for the period ending March 31, 1976.

Vetoed May 1, 1975. The veto message was laid before the House, referred to the Committee on Agriculture, and printed as H. Doc. 94-125. (121 Cong. Rec. 12975). *The House sustained* the veto on May 13, 1975 by a vote of 245 yeas to 182 nays. (121 Cong. Rec. 14094). *Veto sustained.*

2331 H.R. 4481.

Emergency Employment Appropriations Act.

Vetoed May 28, 1975. The veto message was laid before the House, referred to the Committee on Appropriations, and printed as H. Doc. 94-169. (121 Cong. Rec. 16240).

The House sustained the veto on June 4, 1975 by a vote of 277 yeas to 145 nays. (121 Cong. Rec. 16876). *Veto sustained.*

2332 H.R. 4485.

To provide for greater home ownership opportunities for middle income families and to encourage more efficient use of land and energy resources.

Vetoed June 24, 1975. The veto message was laid before the House, referred to the Committee on Banking, Currency, and Housing, and printed as H. Doc. 94-199. (121 Cong. Rec. 20629).

The House sustained the veto on June 25, 1975 by a vote of 268 yeas to 157 nays. (121 Cong. Rec. 20801). *Veto sustained.*

2333 H.R. 5357.

To authorize appropriations to the Secretary of Commerce for the promotion of tourist travel.

Vetoed May 28, 1975. The veto message was laid before the House and referred to the Committee on Interstate and Foreign Commerce. (121 Cong. Rec. 16239).

Veto unchallenged.

2334 H.R. 5559.

To amend section 883(a) of the Internal Revenue Code to provide for exclusion of income from the temporary rental of railroad rolling stock by foreign corporations.

Vetoed December 17, 1975. The veto message was laid before the House, referred to the Committee on Ways and Means, and printed as H. Doc. 94-325. (121 Cong. Rec. 41438).

The House sustained the veto on December 18, 1975 by a vote of 265 yeas to 157 nays. (121 Cong. Rec. 41705).

Veto sustained.

2335 H.R. 5901.

Appropriations for Education Divisions and related agencies, for the fiscal year ending June 30, 1976 and the period ending September 30, 1976.

Vetoed July 25, 1975. The veto message was laid before the House and printed as H. Doc. 94-222. (121 Cong. Rec. 24845).

The House overrode the veto on September 9, 1975 by a vote of 379 yeas to 41 nays. (121 Cong. Rec. 28014).

The Senate overrode the veto on September 10, 1975 by a vote of 88 yeas to 12 nays. (121 Cong. Rec. 28500).

Veto overridden. (89 Stat. 468; Public Law 94-94).

2336 H.R. 8069.

Making appropriations for the Departments of Labor, and Health, Education, and Welfare, and related agencies, for fiscal year ending June 30, 1976 and the period ending September 30, 1976.

Vetoed December 19, 1975. The veto message was laid before the House and printed as H. Doc. 94-326. (121 Cong. Rec. 41880).

The House overrode the veto on January 27, 1976 by a vote of 310 yeas to 113 nays. (122 Cong. Rec. 1035).

The Senate overrode The veto on January 28, 1976 by a vote of 70 yeas to 24 nays. (122 Cong. Rec. 1326).

Veto overridden. (90 Stat. 3; Public Law 94-206).

2337 H.R. 9497.

To amend the computation of the level of price support for tobacco.

Vetoed September 30, 1975. The veto message was laid before the House, referred to the Committee on Agriculture, and printed as H. Doc. 94-271. (121 Cong. Rec. 31103).

Veto unchallenged.

Ninety-fourth Congress, Second Session

To amend the Mineral Leasing Act of 1920, and for other purposes.

Vetoed July 3, 1976. The veto message was laid before the Senate, referred to the Committee on Interior and Insular Affairs, and printed as S. Doc. 94-229. (122 Cong. Rec. 22556).

The Senate overrode The veto on August 3, 1976 by a vote of 75 yeas to 17 nays. (122 Cong. Rec. 25213).

The House overrode the veto on August 4, 1976 by a vote of 316 yeas to 85 nays. (122 Cong. Rec. 25455).

Veto overridden. (90 Stat. 1083; Public Law 94-377).

2339 S. 2350.

To amend the National Security Act of 1947, as amended, to include the Secretary of the Treasury as a member of the National Security Council.

Vetoed December 31, 1975. The veto message was laid before the Senate and printed as S. Doc. 94-145. (122 Cong. Rec. 2).

The Senate overrode the veto on January 22, 1976 by a vote of 72 yeas and 16 nays. (122 Cong. Rec. 679).

The veto message was referred to the House Committee on Armed Services. (122 Cong. Rec. 874).

Veto sustained.

2340 S. 2447.

To amend Title IV of the United States Code to make it clear that members of Congress may not, for purposes of state income tax laws, be treated as residents of any state other than the state from which they were elected.

Vetoed August 3, 1976. The veto message was laid before the Senate and printed as S. Doc. 94-245. (122 Cong. Rec. 25251).

Veto unchallenged.

2341 S. 2662.

To amend the Foreign Assistance Act of 1961 and the Foreign Military Sales Act, and for other purposes.

Vetoed May 7, 1976. The veto message was laid before the Senate and printed as S. Doc. 94-185. (122 Cong. Rec. 13053).

Veto unchallenged.

2342 S. 3201.

To amend the Public Works and Economic Development Act of 1965, to increase the anti-recessionary effectiveness of the program.

Vetoed July 6, 1976. The veto message was laid before the Senate and printed as S. Doc. 94-230. (122 Cong. Rec. 22557).

The Senate overrode the veto on July 21, 1976 by a vote of 73 yeas to 24 nays. (122 Cong. Rec. 23096).

The House overrode the veto on July 22, 1976 by a vote of 310 yeas to 96 nays. (122 Cong. Rec. 23420).

Veto overridden. (90 Stat. 999; Public Law 94-369).

2343 S.J. Res. 121.

To provide for quarterly adjustments in the support price for milk.

Vetoed January 30, 1976. The veto message was laid before the Senate and printed as S. Doc. 94-154. (122 Cong. Rec. 1823).

The Senate sustained the veto on February 4, 1976 by a vote of 37 yeas to 51 nays. (122 Cong. Rec. 2291).
Veto sustained.

2344 H.R. 5247.

To authorize a local public works capital development and investment program.

Vetoed February 13, 1976. The veto message was laid before the House and printed as H. Doc. 94-367. (122 Cong. Rec. 3157).

The House overrode the veto on February 19, 1976 by a vote of 319 yeas to 98 nays. (122 Cong. Rec. 3912).
The Senate sustained the veto on February 19, 1976 by a vote of 63 yeas to 35 nays. (122 Cong. Rec. 3873).
Veto sustained.

2345 H.R. 5465.

To allow federal employment preference to certain employees of the Bureau of Indian Affairs, and to certain employees of the Indian Health Service, who are not entitled to the benefits of, or who have been adversely affected by the application of, certain federal laws allowing employment preference to Indians.

Vetoed September 24, 1976. The veto message was laid before the House, referred to the Committee on Post Office and Civil Service, and printed as H. Doc. 94-624. (122 Cong. Rec. 32490).

Veto unchallenged.

2346 H.R. 5900.

To protect the economic rights of labor in the building and construction industry by providing for equal treatment of craft and industrial workers.

Vetoed January 2, 1976. The veto message was laid before the House and printed as H. Doc. 94-329. (122 Cong. Rec. 145).

Veto unchallenged.

2347 H.R. 8617.

To restore to the Federal civilian and postal service employees their rights to participate voluntarily, as private citizens, in the political process of the Nation, to protect such employees from improper solicitations.

Vetoed April 12, 1976. The veto message was laid before the House, referred to the Committee on Post Office and Civil Service, and printed as H. Doc. 94-449. (122 Cong. Rec. 10561).

The House sustained the veto on April 29, 1976 by a vote of 243 yeas to 160 nays. (122 Cong. Rec. 11867).
Veto sustained.

2348 H.R. 8800.

To authorize certain construction at military installations.
