President Johnson vetoed thirty bills, of which sixteen were regular vetoes and fourteen were pocket vetoes. None was overridden.

To amend the Tariff Act of 1930 to require certain new packages of imported articles to be marked to indicate the country of origin, and for other purposes.

Pocket veto occurred after the 1st session of the 88th Congress had adjourned sine die on December 30, 1963. The bill was presented to the President on December 19, 1963. (109 Cong. Rec. 25431; 110 Cong. Rec. 7).

To confer jurisdiction on the Court of Claims to entertain, hear, and determine a motion for a new trial on the claim of Robert Alexander.

Pocket veto occurred after the 1st session of the 88th Congress had adjourned sine die on December 30, 1963. The bill was presented to the President on December 21, 1963. (109 Cong. Rec. 25465; 110 Cong. Rec. 7).

To incorporate the Youth Councils on Civic Affairs, and for other purposes.

Vetoed September 10, 1965. The veto message was laid before the House, referred to the Committee on the District of Columbia, and printed as H.R. Doc. No. 292. (111 Cong. Rec. 23623).

For the relief of Cecil Graham.

To authorize certain construction at military installations, and for other purposes.

To strengthen the financial condition of the Employees' Life Insurance Fund created by the Federal Employees' Group Life Insurance Act of 1954, to provide certain adjustments in amounts of group life and group accidental death and dismemberment insurance under such Act, and for other purposes.

Vetoed September 12, 1966. The veto message was laid before the House, referred to the Committee on Post Office and Civil Service, and printed as H.R. Doc. No. 495. (112 Cong. Rec. 22411).

For the relief of Gilmour C. MacDonald, colonel, U.S. Air Force (retired).

To establish the past and present location of a certain portion of the Colorado River for certain purposes.

Vetoed August 12, 1967. The veto message was laid before the House, referred to the Committee on Post Office and Civil Service, and printed as H.R. Doc. No. 156. (113 Cong. Rec. 22438).

To amend section 202 of the Agricultural Act of 1956.
