## RESOLUTION

1	Resolved, That a special committee of the Senate, to
2	be appointed by the President of the Senate after March 4,
3	1933, three from the majority political party and two from
4	the minority political party, is authorized and directed to
5	investigate and make a full, complete, and detailed inquiry
6	into all existing contracts entered into by the Postmaster
7	General for the carriage of air mail and ocean mail, both
8	foreign and domestic, with a view to determining particu-
9	larly (1) all the circumstances surrounding the execution
10	and continuation of, and the necessity, if any, of maintain-

ing, altering, or canceling such contracts; (2) the organiza-

tion and financial condition of the associations, partnerships 1 or corporations with which such contracts have been entered  $\mathbf{2}$ into, including a study of their capital stock, authorized and 3 paid in, their receipts and expenditures, their total outlay 4 in salaries paid to officers, executives, and employees, 6 whether by way of bonus or otherwise, and their relationship, whether by interlocking directorates or otherwise, 8 with any other individual, association, public official, partner-9 ship, or corporation, commercial or banking; (3) the extent 10 of any activities by or on behalf of any association, partner-11 ship, or corporation with which such contracts have been 12 entered into, in any effort to obtain, through legislation or 13 otherwise, cash subsidies from the United States; and (4) any other facts relating to legislation or appropriations 14 15 affecting air mail and ocean mail contracts, both foreign and 16 domestic. The committee shall report to the Senate, as soon as practicable, the results of its investigations, together with 18 its recommendations. For the purposes of this resolution the committee, or 20 any duly authorized subcommittee thereof, is authorized to 21 hold such hearings, to sit and act at such times and places 22 during the sessions and recesses of the Senate in the Seventy-23 second and succeeding Congresses, to employ such clerical 24 and other assistants, to require by subpæna or otherwise 25 the attendance of such witnesses and the production of

- 1 such books, papers, and documents, to administer such
- 2 oaths, to take such testimony, and to make such expendi-
- 3 tures, as it deems advisable. The cost of stenographic
- 4 services to report such hearings shall not be in excess of
- 5 25 cents per hundred words. The expenses of the com-
- 6 mittee, which shall not exceed \$5,000, shall be paid from
- 7 the contingent fund of the Senate upon vouchers approved
- 8 by the chairman.
