UNANIMOUS CONSENT AGREEMENT

Ordered, That on Monday, May 8, 1961, at the conclusion of routine morning business, debate on the nomination of Julius C. Holmes, of Kansas, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to Iran, be proceeded with for 2 hours; that the time be equally divided between those favoring and those opposing confirmation, and controlled, respectively, by the majority leader and Mr. Williams of Delaware; and that at the conclusion of the 2 hours, the yeas and nays be considered as ordered on the said nomination and the Senate then proceed to vote thereon.
