UNANIMOUS CONSENT AGREEMENT

Ordered, that on Tuesday, July 13, 1982, at 4:00 p.m. the Senate go into Executive Session to consider the nomination of James Stearns to be Chairman of the Securities Investor Protection Corporation, under the following time agreement:

1 hour to be equally divided between the Chairman of the Banking Committee and the ranking Minority member, or their designees;

Ordered, further, that following the vote and any motion to reconsider, and table, and the informing of the President that the Senate has given its consent to this nomination, the Senate resume the pending business.
