All nominations remaining on the Executive Calendar, under the rules of the Senate, failed of confirmation at the time of the sine die adjournment of the Senate and are returned to the President (together with other nominations received by the Senate and unacted upon by the committees to which they had been referred), and must be resubmitted in the next Congress to be further considered.
