## UNANIMOUS CONSENT AGREEMENT

*Ordered*, that the vote on the nomination of Richard R. Burt to be an Assistant Secretary of State occur at 2 p. m. on Wednesday, February 16, 1983;

*Ordered, further*, that the time for debate until 2 p. m. on Wednesday, February 16, 1983, in relation to either the above nomination or the nomination of Richard T. McCormack to be an Assistant Secretary of State, be equally divided and controlled by the majority and minority leaders or their designees, and that the vote on the Burt nomination be immediately followed by a vote on the McCormack nomination, and that there be no time for debate on reconsideration of either of these votes;

*Ordered, further*, that at 10:30 a. m. on Wednesday, February 16, 1983, the Senate go into closed session for not to exceed one hour for the purpose of receiving classified information with the time to be equally divided and controlled by the majority and minority leaders or their designees, and that after the debate in closed session the Senate resume open executive session.
