Unanimous Consent Agreement

Ordered, That on Wednesday, March 1, 1989, at 12 noon, the Senate go into executive session to consider the nomination of Louis W. Sullivan to be Secretary of Health and Human Services (Cal. No. 12), under a time agreement of one hour equally divided and controlled between the Senator from Texas (Mr. Bentsen) and the Senator from Oregon (Mr. Packwood), or their designees; provided that no motions be in order and that at 1:00 p.m., the Senate proceed without any intervening business to a 15 minute vote on the nomination. (yeas and nays ordered)

Provided further, That upon the disposition of the nomination the motion to reconsider be laid on the table and that the President be immediately notified of the confirmation of the nomination.
