#### Unanimous Consent Agreement

Ordered, That when the Senate resumes executive session at 9 a.m. on Wednesday, September 30, 1992. a vote occur on or in relation to Amendment No. 3270 (Ex.), without intervening action or debate; that following disposition of the Wallop amendment, the treaties be advanced through their various parliamentary stages up to and including the presentation of the Resolution of Ratification; that the committee-reported amendment be considered agreed to and treated as original text for the purpose of further amendments; and that the following be the only amendments in order, if timely filed and germane, and subject to the following time limitations:

Pressler No. 3227. 20 minutes equally divided; Wallop No. 3283, 30 minutes equally divided; Warner No. 3243, 20 minutes equally divided; and Warner No. 3240. one hour equally divided;

Ordered, further, That a vote occur. without any intervening action or debate, on the Resolution of Ratification, as amended, at 9:30 a.m., on Thursday, October 1, 1992; and

Ordered, further, That prior to the disposition of the final amendment to the Resolution of Ratification, the Senate resume legislative session only for consideration of routine morning business and legislative items that have been cleared by the two leaders; and that upon disposition of the final amendment to the Resolution of Ratification all provisions of Rule XXII cease to be in effect.
