## Unanimous Consent Agreements

*Ordered.* Cloture motions having been filed on five Department of State nominations--Alan Blinken to be Ambassador to Belgium (Cal. No. 411), Tobi Gati to be an Assistant Secretary of State (Cal. No. 413), Swanee Hunt to be Ambassador to Austria (Cal. No. 414), Thomas Loftus to be Ambassador to Norway (Cal. No. 415) and Daniel Spiegel to be U. S. Representative to the European Office of the United Nations (Cal. No. 420)--That these cloture motions be voted on, en bloc, and that the cloture vote occur at 2:15 p.m. on Tuesday, November 2, 1993, with the mandatory quorum under Rule XXII being waived; and

*Ordered, further,* That if cloture is invoked, there be 90 minutes equally divided between Senators Pell and McConnell, or their designees, and that following the conclusion or yielding back of time, the Senate proceed to vote, without any intervening action, on the confirmation of the above mentioned nominations, ad seriatum; that the motions to reconsider be laid upon the table; that the President be notified of the action of the Senate; and that the Senate return to legislative session.
