Unanimous Consent Agreement

Ordered, That at 9:30 a.m. on Thursday, April 14, 1994, the Senate proceed to executive session and consideration of the nomination of Rosemary Barkett to be U. S. Circuit Judge for the Eleventh Circuit; that there be six hours for debate to be equally divided and controlled by the chairman and ranking member of the Committee on the Judiciary or their designees; that at the conclusion or yielding back of time, without intervening action, the Senate vote on the nomination; that, if confirmed, the motion to reconsider be tabled and the President be immediately notified of the action of the Senate; and

Ordered, further, That the cloture motion filed on April 12, 1994, on this nomination be vitiated.
