#### **Unanimous Consent Agreement**

No. 1096); that there be six hours for debate, to be equally divided and controlled by the Chairman and Ranking Member of the Committee on the Judiciary or their designees; that following the use or yielding back of time, without any intervening action, the Senate vote on the nomination; that if confirmed, the motion to reconsider be tabled; that the President be immediately notified of the action of the Senate; and that the Senate return to legislative session.
