## UNANIMOUS CONSENT AGREEMENTS

*Ordered*, That on Monday, May 7, 2001, the Senate proceed to executive session to consider the nomination of John Robert Bolton, of Maryland, to be Under Secretary of State for Arms Control and International Security (Calendar No. 39), and that there be three hours of debate divided as follows:

- 30 minutes under control of the Chairman (Mr. Helms);
- 30 minutes under the control of the Ranking Member (Mr. Biden);
- 60 minutes under the control of Mr. Dorgan;
- 30 minutes under the control of Mrs. Feinstein; and
- 30 minutes under the control of Mr. Kerry.

*Ordered further*, That following the use of time, the Senate proceed to executive session to a vote at 9:30 a.m. on Tuesday, May 8, 2001, on the confirmation of John Robert Bolton, and following the vote, the President be immediately notified of the Senates action, the motion to reconsider be laid upon the table, and the Senate immediately return to legislative session.

*Ordered*, That at 4:00 p.m. on Monday, May 7, 2001, the Senate proceed to executive session to consider the nomination of John Robert Bolton under the time agreement listed in the order of May 3, 2001.

*Ordered further*, That at 9:30 a.m. on Tuesday, May 8, 2001, the Senate proceed to executive session to resume consideration of the nomination of John Robert Bolton and that there be 45 minutes equally divided between the Chairman of the Committee on Foreign Relations (Mr. Helms), the Ranking Member (Mr. Biden) and the Senator from North Dakota (Mr. Dorgan) and that the vote occur at 10:15 a.m.
