UNANIMOUS CONSENT AGREEMENT

Ordered, That on Thursday, July 12, 2001, the Majority Leader (Mr. Daschle), after consultation with the Republican Leader (Mr. Lott), may turn to the consideration of Calendar No. 104, the nomination of John D. Graham, of Massachusetts, to be Administrator of the Office of Information and Regulatory Affairs, Office of Management and Budget.

Ordered further, That the nomination be considered under the following time limitation:

- 1 hour under the control of Mr. Lieberman;
- 3 hours under the control of Mr. Thompson;
- 2 hours under the control of Mr. Durbin;
- 2 hours under the control of Mr. Wellstone;
- 15 minutes under the control of Mr. Kerry.

Ordered further, That upon the use, or yielding back, of time the Senate vote on the nomination at a time to be determined by the Majority Leader and the Republican Leader; and that upon the disposition of the nomination the President be immediately notified of the Senates action and the Senate return to legislative session.
