## UNANIMOUS CONSENT AGREEMENT

*Ordered*, That at 5:45 p.m. on Monday, November 5, 2001, the Senate proceed to executive session and the consideration of the nomination of Larry R. Hicks, of Nevada, to be United States District Judge for the District of Nevada (Cal. No. 515); that there be 15 minutes of debate divided equally between the Chairman of the Committee on the Judiciary (Mr. Leahy) and the Ranking Member (Mr. Hatch) or their designees; and that at 6:00 p.m., without intervening action or further debate, the Senate vote on the confirmation of the nomination.
