## UNANIMOUS CONSENT AGREEMENT

*Ordered*, That on Monday, May 13, 2002, at 4:00 p.m., the Senate proceed to executive session to consider the nomination of Paul G. Cassell, of Utah, to be United States District Judge for the District of Utah (Cal. No. 815); that there be two hours divided equally between the Chairman of the Committee on the Judiciary (Mr. Leahy) and the Ranking Member (Mr. Hatch), or their designees.
