## UNANIMOUS CONSENT AGREEMENTS

### **Miguel A. Estrada (Cal. No. 21)**

*Ordered*, That relative to the cloture motion presented on the nomination of Miguel A. Estrada, the mandatory quorum under Rule XXII be waived. (*March 31, 2003*)

*Ordered*, That at 1:30 p.m. on Wednesday, April 2, 2003, the Senate return to executive session to resume debate on the nomination of Miguel A. Estrada, of Virginia, to be United States Circuit Judge for the District of Columbia, that there be 30 minutes for debate equally divided in the usual form prior to the cloture vote; and that if cloture is not invoked the Senate then return to legislative session.
