## UNANIMOUS CONSENT AGREEMENT

### Victor J. Wolski (Cal. No. 88)

*Ordered*, That on Wednesday, July 9, 2003, following the cloture vote on S. 11, the Senate proceed to executive session and immediately vote on the confirmation of Victor J.
