UNANIMOUS CONSENT AGREEMENTS

(THOMAS B. GRIFFITH [CAL. NO. 66])

Ordered, That at 2:30 p.m. on Monday, June 13, 2005, the Senate proceed to the consideration of the nomination of Thomas B. Griffith, of Utah, to be United States Circuit Judge for the District of Columbia Circuit; provided further, that there be 4 hours equally divided for debate on the nomination between the Chairman of the Committee on the Judiciary and Ranking Member or their designees; provided further, that following the use or yielding back of time the Senate then resume legislative session.

Ordered further, That the vote occur on the confirmation of the nomination at 10:00 a.m. on Tuesday, June 14, 2005.

SEQUENTIAL REFERRAL

Ordered, That the nomination of Edmund S. Hawley, of California, to be Assistant Secretary of Homeland Security be referred to the Committee on Commerce, Science, and Transportation, and that, further, upon the reporting out or discharged of the nomination, the nomination be referred to the Committee on Homeland Security and Governmental Affairs for a period not to exceed 30 days, after which time the nomination, if still in committee, will be discharged and placed on the Executive Calendar.
