UNANIMOUS CONSENT AGREEMENT

Anthony J. Battaglia (Cal. No. 4) Sue E. Myerscough (Cal. No. 32) James E. Shadid (Cal. No. 33)

Ordered, That at 4:30 p.m. on Monday, March 7, 2011, the Senate proceed to executive session to consider the nominations of Anthony J. Battaglia, of California, to be United States District Judge for the Southern District of California, Sue E. Myerscough, of Illinois, to be United States District Judge for the Central District of Illinois, and James E. Shadid, of Illinois, to be United States District Judge for the Central District of Illinois; that there be one hour for debate, equally divided and controlled in the usual form; that, upon the use or yielding back of time, the nomination of Sue E. Myerscough be confirmed; that the Senate then vote first on confirmation of the nomination of James E. Shadid, and then on confirmation of the nomination of Anthony J. Battaglia, without intervening action or debate; that motions to reconsider be considered made and laid on the table; that no further motions be in order; that the President be immediately notified of the Senate's action, and the Senate then resume legislative session.


