UNANIMOUS CONSENT AGREEMENT

Ordered, That at 2:15 p.m. on Thursday, March 10, 2011, the Senate proceed to executive session to consider the nomination of Max Oliver Cogburn, Jr., of North Carolina, to be United States District Judge for the Western District of North Carolina; that there be 15 minutes for debate equally divided in the usual form; that upon the use or yielding back of time, the Senate proceed to vote, without any intervening action or debate, on confirmation of the nomination; that no further motions be in order; that upon confirmation, the motion to reconsider be considered made and laid upon the table, the President be immediately notified of the Senate's action and the Senate then resume legislative session.

When a notice of intent to object is given to the appropriate leader, or their designee, and such notice is submitted for inclusion in the Congressional Record and the Senate Executive Calendar, or following the objection to a unanimous consent to proceeding to, and, or disposition of, matters relating to nominations and treaties on their behalf, it shall be placed in the section of the Senate Executive Calendar entitled "Notice of Intent to Object".
